General Rules for Three Years Law Course Vikram University, Ujjain (Semester System)

- 1. The Course for L.L.B. shall be of three years duration. All the colleges shall be whole time (day) colleges. The colleges which are exclusively running morning session will switch over the day session from the academic year 2008-2009. The students who were admitted to the 1st year in the morning/evening session during the academic session 1999-2000 shallbe allowed to complete the course.
- 2. "Candidates seeking admission to the LL.B. degree course must have passed B.A., B.Sc., B. Com. or other qualifying examination from any recognized University and must have secured minimum percent of marks specified under the Admission rules notified by Commissioner. Higher Education. Govt. of Madhya Pradesh from time to time.
- 3. The Candidates for the LL.B. Degree will be required to pass six semester exminations, which will be held in the month of December and May of each academic year.
- 4. The Students shall be required to put in a minimum attendance of

75% of the lectures on each of the subjects as also at tutorials. moot courts and practical training course.

Provided that in exceptional cases for reasons

- to be recorded and communicated to the Bar Council of India. The Dean of the faculty oF Law and the Principal Of Law Colleges may condone attendance Short of those required by the Rule. If the students had attended 60 % of the lectures in the aggregate for the semester or examination as the case may be.
- 5. A Candidate who. after taking to Bachleor's degree of this University or ofany other University recognized for this purpose, has Completed a regular course of study of law in a constituent or an affiliated College of this University for an academic semester shall be eligible for appearing in that aforesaid examination.
- A Candidate who passed LL.B. First year of Second year from other Examination University. which has introduced either Semester pattern or Annual Examination pattern or Three Year Degree Course in Law after 3 years graduation will not be admitted to III semester (II year) or Vth semester (III year) of LL.B. course unless he has passed the I & II both Semesters (I yaer) of III& IV both semesters (II year) Examination from the University concerned and provided further that the course is of equivalent standard with almost identical syllabus as is required for the respective examination of this

University. Provided that if a candidate who passed the LL.B. First (I & II Semester both) or Second year (III & IV Semester both) Examination from some other University. desire to appear at the LL.B. Second or Final Year Examination of this University i.e. III or IV Semester respectively of this University. he will be required to appear. alongwith the papers prescribed for the LL.B. second year (III & IV Semester) or Third year (V & VI Semester) in such papers of the previous years examination of this Univerity as did not from the part of the curriculum for LL.B. First year of LL.B; Second year Examination of the University from which he the passed examination.Provided further that a candidate who has passed from other University in one or more subjects but not in all the subjects included in a paper for the LL.B. First or Second Year Examination of this University would not be exempted from appearing at the said paper of the LL.B. First or Second Year of this University while appearing at LL.B. Second FinalExamination under above rule: Provided that Nothing in these regulation/ordinances shall interface with the right of a principal to disallow any combination of course of study in his college

- 7. Rules for promotion to the next higher class (Semeter/Academic Year)
- The examinations will be held odd to odd and even to even semester pattern only.

- (ii) If a candidate cleared in all papers but unable to make aggregato 48 % then result -ATKT.
- (iii) If a candidate has covered aggregate 48% but failed in 1 or 2 subject, then result will be ATKT.
- (iv) If a candidate has cleared all papers and aggregate 48% covered than result will be pass.
- (v) If a candidate has covered 48% aggregate but failed in more than 2 papers then result will be fail.
- (vi) If a candidate has got less then 48% aggregate and failed in any papers than result will be fail.
- (vii) If candidate carries backlog in 4 subjects than he is promoted to next semester.
- (viii) If a student has to be admitted in fifth semester than he has to clear all the four semesteres.
- (ix) The sessional marks regarding examination will comprise of 80 Marks Theoretical and 20 marks practical (viva-voce).
- 8. Revaluation of answer books be allowed as per provision of Ordinance.
- 9. The subjects and papers for each year of LL.B. shall be prescribed by the Faculty of Law on the recommendations of the board as Studies. Unless provided each paper will carry 100 marks and will be of 3 hours duration.
- 10.If not provided otherwise the

candidate will have to pass seperately in written peper and principal if any prescribe.

The minimum pass marks 11. in each semesters examination shall be 48 percent in the aggregate of all the papers and 36 percent marks in each individual paper. Division to successfull candidates for the LL.B. degree will be assigned at the end of Final Year Examintion on the basis of the aggregate of the total marks obtained by him at the LL.B. First Year Second Year and Final Year Examination i.e. all Six Semesters as under. First: 60 No third division shall be awarded.

Second Division: 48 perecent or above of the aggregate marks.

Candidates who obtain

75 percent or more marks in the aggregate shall be declared to have passed the LL.B. degree course in the First Division with distinction.

- (iii) V.C.Grace marks as per rules can be awarded.
- **12.** for each paper there shall be lecture classes for atleast 3 hours per week.
- 13. Candidates appearing for the LL.B. Examinations shall have the option of answering questions through the medium of Hindi (Devngri Script) or English.
